County **MUST** approve increases/decreases in rate(s) prior to any change. Company shall follow all current rulings set by the Federal Communications Commission (FCC) on inmate telephone rates and fees.
- **Page 20 Commission Offer Form**
The following is to be removed: Each vendor must submit an offer based upon the current rates as stated in the RFP.
- **Video Visitation**
The County is interested in offering Video Visitation. At this time the County offers no such services to the inmates.
- **Requirement 14 on page 6**
Bid bonds are not required for this proposal. However, a Performance Bond is required in the amount of 100% of projected annual commissions for the new contract.
- The current JMS vendor is Global Tel.
- **Service and Support Requirements (pg. 11)**
Number 4 shall be removed from the RFP. This shall be a cloud based system.
- It is the goal of the County to bring in new technology such as video visitation and tablets. Please include all services offered by your company.
- Sebastian County currently has one (1) work release inmate.
